- 7. Electronic bids must be submitted to the office swami Kartik khapar Rural Municipality through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 pm 2077/12/04 (17-Mar-2021) Bids received after this deadline will be rejected.
- 8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 pm 2077/12/04 (17-Mar-2021)at the office of Swami Kartik Khapar Rural Municipality Suijiula Wai Bajura. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of (In NRs.) mentioned in the above Table which shall be valid for 30 days beyond the validity period of the bid.
