7. Bids must be submitted to the above Swamikartik Khapar Rural Municipality Office, Suijuila wai, Bajura by hand on or before the specified date and time as shown in table below. Documents received after this deadline shall not be accepted.

The bids will be opened in the presence of Bidders' representatives who choose to attend at the specified date and time as shown in table below at the Swamikartik Khapar Rural Municipality Suijuila wai Bajura. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security, amounting to a minimum of as shown in table below, which shall be valid for 30 days beyond the validity period of the bid (120 days).
