- Minimum Work experience of similar size and nature: (at least one contract for Track opening of Earthwork excavation Road work or up-grading Earthwork excavation of work or Any pavement of road projects with construction side drain, retaining structures, of road work) with value of each project is Nrs 1,60,76,886.00
- Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
